Dr. Jones submits a rebate form on March 15, 2018, with a total spend of \$25,000 (tax and shipping excluded). We send him a 2% rebate immediately.

JANUARY 16, 2019
REBATE FORM #2

➔ **2.5%
REBATE**

Dr. Jones submits a second rebate form on January 16, 2019, with a total spend of \$60,000 (tax and shipping excluded). Since his total spend is \$85,000 within a 12-month period, his second rebate will be 2.5% on the \$60,000 (since he already received a rebate on the first \$25,000 purchase).
