

Notes

Midmark's standard policy on disinfecting medical equipment, which is printed in the Care and Maintenance portion of the User Guides, is to use a solution of bleach and water mixed in a 1:10 ratio (10%) to disinfect the upholstery.¹ This should be followed with a clear water rinse and thorough drying of material. Any deviation from this recommendation could risk damage to the upholstery, possibly causing premature cracking, staining or discoloration.

For convenience you may wish to purchase a premixed disinfecting solution in spray or wipe form. Bleach based products manufactured with a 1 in 10 ratio (10%) have been shown to be compatible. The following off the shelf disinfecting solutions have been tested by an independent lab and deemed safe for use on our upholstery and all surfaces of our exam and procedure tables. This list supersedes all previous versions (before April 2018).
